2011 Business Meeting Minutes

Thursday, November 3, 2011

Chris Keegan welcomed the Western Bridge Preservation Partnership (WBPP) membership to its second annual meeting in St. Louis and asked each attendee in turn to introduce himself/herself to the assembled group. The morning session of WBPP the consisted of small group breakouts in a Peer Exchange format, using five discussion topics, generated by the steering committee as a starting point:

Gregg Gaddy, NCPP / TSP·2 IT Specialist presented information about the TSP·2 Forum, how to access it and how to post questions and replies. An RSS feed is being developed, as is the specialized Bridge Preservation Search Engine. Mike Brown, Virginia Center for Transportation Innovation and Research (VCTIR) will be working in conjunction with the NCPP IT department on the internet tools.

Chris Keegan (Washington DOT), Chair, Western Bridge Preservation Partnership (WBPP) opened the meeting at 3:00 pm (sign in membership list attached), and called for nominations to fill vacant committee positions.

To assist in spreading out the upcoming meeting schedule and avoid the logiam that often happens in the fall, the partnership agreed to target a May 2012 meeting date.

WBPP Action Items Identified for 2011-2012

The following list of actions were generated after considerable discussion and input by the entire WBPP group of meeting attendees. The Action Items are a guideline for the areas that should receive focus throughout the upcoming year (Working Group leads and members will be developed during the next teleconference):

• **Bridge Preservation Guide:** The group agreed that a manufacturer action and product manual, is needed that would be unique to each bridge and contain preservation related elements. This

information Guide will assist in future decisions for maintenance / preservation work, much like the maintenance and service manuals provided by automobile manufacturers, and would include:

- List of Actions for maintaining, both cyclical and preventive (all of which are thought to be bridge preservation techniques), to be utilized to extend the bridge life. Examples are washing the bridge deck, sealing, etc.
- Suggested products to use and those originally applied to the structure.
- Appropriate action / strategic intervals
- Cost of inaction (Chris Keegan, lead; Dave Severns, Nevada DOT, and Mike Gehring, Oregon DOT volunteered to assist).
- **Toolbox** Development; working with other Partnerships, Long Term Bridge Project and the BPETG to enhance bridge life extension.
- Research
 - Continue to forward whatever relevant research is being done to TSP·2 website for posting; development of region-specific research topics; sorting of relevant preservation topics; advocate Bridge Preservation on an individual and group basis; forward recommendations to SCOBS & SCOM considering the competition for research funds. (Paul Jensen, lead)
 - NCHRP review of ongoing projects and consideration for additional projects
- Qualifying a Systematic Preventive Maintenance Program (SMP) for FHWA funds -
 - Determine which Western states have qualified their programs for FHWA funding and how they succeeded.
 - Determine which states have not been able to qualify their programs for FHWA funds and assist those who are to develop a qualifying program. (Bert Hartman, Oregon DOT, lead; Anwar Ahmad, FHWA will assist with questions)
